I. Scope of Work

A. Preliminary Design Stage

- 1. Study the architectural drawings provided and obtain necessary clarifications.
- 2. Undertake site visits, if required, to collect design-related data such as existing structural conditions, services layout, etc.
- 3. Prepare and submit preliminary structural arrangement drawings/marking plans for all proposed structures (buildings, water tanks, retaining walls, etc.) for review.
- 4. Carry out structural analysis and design using approved licensed versions of standard software packages (e.g., ETABS, STAAD, etc).
- 5. Perform structural analysis and design in compliance with the latest IS Codes, including provisions for seismic, wind, and other applicable loads.
- 6. Ensure structural safety, serviceability, durability, and economy in design.

- 2. Provide signed & certified "Good for Construction" (GFC) drawings and issue revisions in line with site requirements.

- 3. Carry out modifications/additions/deletions in design/drawings during construction, as required by the Client/Consultant/Architect/MEP services.
- 4. Provide clarifications and respond to comments, including those in Project Execution Documents (PED) and Observation Memos (OM), raised by the Client/Funding Agency/Vetting Agencies (e.g., Kerala Infrastructure Investment Fund Board, Indian Institute of Technology) and KITCO Engineers.
- 5. Co-ordinate with other consultants (Architectural, MEP, Landscape, etc.) to avoid service clashes and ensure smooth execution.
- 6. Provide additional detail drawings/sketches for site-specific requirements and unforeseen conditions.
- 7. Assist in resolving technical/site issues related to structural design.
- 8. Certify structural safety/stability of temporary works (staging, scaffolding, formwork systems, shop drawings, etc.), where required.
- 9. Submit the final design report containing design basis, load calculations, analysis output, and a summary of the structural design.
- 10. Provide the structural stability certificate for the project.
